The purple **SIDE BAR** gives access to Skyjed's tools to plan, design and review. Now let's **ADD A PRODUCT**!



To create your Product Design go to step 3 or to start Product Reviews straight away skip to step 4.




START PRODUCT DESIGN 5 mins

PRODUCT LEVEL INSIGHTS

On the **INSIGHTS** tab, check out the **PRODUCT HEALTH CHECK DASHBOARD** providing you with your product's health performance ratings based on your audit data. The **RISK AND STRATEGY ACTIONS DASHBOARD** populates any risks or strategy actions you created in your audits giving you visual indicators of risk and strategies for better prioritisation. The **PERFORMANCE INSIGHTS DASHBOARD** charts key performance metrics based on your data. Click through on the data metrics to direct you to your related audit data.

TIPS AND A BIT OF JARGON

PLAN PRODUCT REVIEWS IN ADVANCE

In your Product Workspace click on the Planner Page, select ADD EVENT, click on AUDIT and choose from Skyjed's pre-built AUDIT TEMPLATES. Follow the information prompts to schedule your product review event details and due date.

Once scheduled receive reminders and notifications to stay one step ahead. Plan strategic Product Reviews in advance and review the PLANNER page for what is coming up!

PRODUCT HEALTH CHECK SCORE

Skyjed AUDIT TEMPLATES are developed with a selection of ratings to evaluate the financial and non-financial metrics you populate in the drivers within each domains. When you publish your reviews Skyjed provides a health check score that you can access at anytime on the INSIGHTS tab in your Product Workspace.

This is a valuable indicator of product health areas requiring attention; whether these are risks or opportunities, these insights are at your disposal to make strategic data driven decisions.

This is the 3 dot icon offering more actionable tools within the page you are on, click on it to check what's available. For example, on the products page you can edit product details or duplicate items and on the Product Audit Workspace you can import data.

CREATE YOUR OWN TEMPLATES AND DRIVERS*

Developing your own templates is super easy, click SETTINGS and select DESIGN TEMPLATES or AUDIT TEMPLATES, and CREATE TEMPLATE. Check the DRIVERS that you would like to include in your template, these are information prompts for financial and non-financial metrics. Update the status of the template to active and you can now select them in your Product Designs or Product Reviews.
